The purpose of this communication is to outline the process for submitting completed applications to CIGNA for CIGNA Medicare Services products:

- CIGNA Medicare Access® (PFFS), a Medicare Advantage PFFS plan available with or without integrated Part D<sup>1</sup>
- CIGNA Medicare Select Plus Rx® (HMO), a Medicare Advantage HMO plan with integrated Part D<sup>2</sup>
- CIGNA Medicare Rx® (PDP), a stand-alone Medicare Part D prescription drug plan<sup>3</sup>
